The following documents are required for all contract packages:

- Crescent Approval (Valid for 30 days or until 1 day before first payment)
- **Original Contract -** (Laser each page must be initialed)
- Credit Application completed and signed
- \_\_\_\_\_Buyer's Order
  - Invoice (new vehicles) or Bookout (used vehicles)
- \_\_\_\_\_Title Application reflecting ELT Code and Crescent Bank as lienholder at PO Box 245,
- Addison, TX 75001.

All applicants must be on title.

- PA MV1 if New and MV4 if Used
- **OK** Lien Entry Form required
- NJ PO Box 61813, New Orleans, LA 70161
- NV- Guarantee of Title Acceptable

\_\_\_\_\_**References - (5)** personal references including name, relationship, and complete phone number.

**\_\_\_\_Driver License** - All applicants must have a current valid Driver's License. Include a clear legible copy with funding package. ID Cards & Learners Permits are not eligible.

**Proof of Income** - Minimum 90 days on current job at time of application.

- <u>Wage Earner</u> Current paystub (must be the most recent pay period); W2's accepted up to 3/31 of current year.
- NOT ELIGIBLE: Self Employed, Ride Share and App Delivery Drivers
- <u>1099 / Contract Employee</u> 3 months consecutive personal bank statements (NSF's/overdraft not permitted)

Auto Insurance Coverage - All applicants must be insured. \$1000 max deductible; 6-month policy required. Lienholder/Loss Payee

- For faster funding, ensure the vehicle is covered and all applicants are insured.
- Warranty Binder (Min. 24 mo. / 24K miles)
- GAP Binder (Effective 9/1: CBT GAP NOT ELIGIBLE)
- \_\_\_\_\_Miscellaneous Stipulations as listed on Approval
- Assignment Letter if contract not assigned to CBT

**Odometer Statement -** if no odometer statement on Title Document or Buyers Order.

**Proof of Residence** - Only required if stipulated on the call back. Must be dated within last 30 days.

Acceptable POR documents include Cell Phone Bill (excluding prepaid cell phone), Utility Bill, Bank/Mortgage Statement, Credit Card Statement (if listed on bureau), Military Orders (military residing in barracks).

**Contract must be received by Crescent Bank within 20 days of Approval.** Loan Decision valid for 30 days from approval date or until 1 day before first payment date, whichever is sooner.
