- Both Options might be eligible for NMAC Customer Captive Cash. Captive Cash may vary by location. Please refer to the VIN/ZIP lookup on NNAnet → Nissan Incentive Award Site. Customer Cash programs for Special APR are Special APR "OR" Cash. If the full NNA cash option is taken, NMAC standard rates must be used. Dealer Choice 60, 72 and 75 month terms are not eligible for Customer Cash.
- Dealer Choice rates are for **new select models** and cannot be advertised.
- **Dealer Participation for Dealer Choice APR:**
 - Dealers that have adopted NMAC's NADA Fair Credit Compliance Policy and Program have selected a Dealer Participation rate of 200bps or lower, for all NMAC new and used retail contracts that are eligible for Dealer Participation. Dealers will receive their Dealer Participation rate for Dealer Choice APR contracts. Dealers can only offer a lower participation rate based on set criteria. Dealer must record and document any downward deviation from the Dealer Participation rate by completing a Dealer
 - Participation Certification Form and retaining it in the deal jacket. Please see the NMAC Signature Plan Parameters or contact your FSM for more information.
 - Dealers that have not adopted the NADA Fair Credit Compliance Program are enrolled in the standard NMAC Retail Dealer Participation Option for all NMAC retail contacts that are eligible for Dealer Participation. This option provides a maximum Dealer Participation rate of 100bps and applies to Dealer Choice APR contracts.
 - Signature GRADUATE Dealer Participation cannot exceed 50bps on Dealer Choice APR.
 - Dealer will receive the greater of the Dealer Reserve or the 1% Flat Fee if Dealer Participation is used.
- Tier Scored = Tier Booked for 84-Month Term
- Customers with Special Pre-Approval and Tier Adjustment Programs (i.e. VRU) that score below Tier 3 are not eligible for 84-month term contracts.
- SignatureGRADUATE is not eligible for 84-month term contracts.
